## **GUIDELINES FOR PREPARING DETAILED PROJECT REPORT( DPR):**

The NIFS funding scheme (Internal Funding by NIFTEM) aims to encourage the innovative research and development ideas of NIFTEM students (B.Tech/M.Tech/MBA) in the food processing and allied areas. The work should result into proof-of-concepts, design of equipment, etc, thus having high societal and commercial impact and thereby helping in the growth of food processing industry. Some of the best and successful NIFS project may also get chance to support for IPR as per rules.

Project Funding (food processing and allied areas only): upto Rs. 15 Lakhs (or) as per the approval of the competent authority

> Time Period: upto 2 years (maximum)

- > (2) Short listed project will be called for presentation.
- > (3) <u>Project budget, time and final selection of the project would be as per NIFTEM-NIFS rules only.</u> NIFTEM decision is final at any stage.
- ➤ (4) After sanctioning of the project, students has of submit the timely progress report of the project and statement of expenditure, etc as per time schedule (or) any time requested by NIFTEM.
- > 5) Publication/IPR/etc from the project should be done only after due approval of NIFTEM competent authority.
