Subject: CAS application of Dr. Anurag Singh — Reg.

The application of Dr. Anurag Singh, Assistant Professor under Career Advancement Scheme (CAS) for promotion from Level 10 to Level 11 and from Level 11 to Level 12 is scrutinized as per 2018 UGC Regulations.

The UGC Regulations, 2018 in Para-6.3 VII inter-alia provides that the cases pending under CAS for promotion from one Academic Level/Grade Pay to another Academic Level/Grade Pay under the 2010 UGC Regulations and its subsequent Amendments shall be given the option to be considered for promotion from one Academic level/Grade pay to another Academic Level/Grade Pay either to be considered for promotion as per the Regulations, 2018 or under the Regulations, 2010 and its amendments with relaxation in the requirements of API based performance based appraisal system upto the date of notification of these regulations (2018).

The relaxation in the requirements is defined as: (a) Exemption from scoring under category-I as defined in the Appendix-III of the above mentioned UGC Regulations, 2010 and its amendments including 4<sup>th</sup> Amendment in Regulations 2016. (b) Scoring in category-II and category-III under UGC Regulations, 2010 with the combined minimum API score requirement for category-II and category-III taken together as mentioned below.

(There shall be no minimum API score requirement for category-I and category-III individually).

Dr. Anurag Singh joined NIFTEM w.e.f. 09.07.2014 as Assistant Professor. He has rendered past services as Assistant Professor w.e.f. 23.09.2005 to 08.07.2014 in Raja Balwant Singh Engineering Technical Campus, Agra. The same are counted towards promotions under CAS in terms of clause 10 of UGC Regulations dated 18.07.2018. The total Past Service is 08 Years, 09 Months and 07 Days.

Past Services:

- A. Dr. Anurag Singh has claimed for counting the past service from 23.09.2005 to 08.07.2014 as Assistant Professor in Raja Balwant Singh Engineering Technical Campus, Agra.
- B. He fulfils Educational qualifications, Pay scale and Selection procedure criterion for counting the past service.

Promotion:

Situation-I

As per the above said provisions the Date of Eligibility of Dr. Anurag Singh for Promotion to Level 11 is 09.07.2014 and the assessment period from 23.09.2005 to 09.07.2014. For Promotion from Level 11 to Level 12 the assessment period is w.e.f 09.07.2014 to 09.07.2019.

For stage 1 : His API Score is 420 (category-II & III) and also fulfils the eligibility for promotion to Level 11 w.e.f. 09.07.2014.

For stage 2 : From Level 11 to Level 12 his total API Score is for category II & III is 728 and fulfils the requirements of minimum 140 score taken together for both the stages.

He is eligible for promotion to Level 12 is w.e.f. 09.07.2019.

Situation-II

Dr. Anurag Singh has claimed past service from 01.10.2010 to 08.07.2014 with AGP of Rs. 7000/- and requested for the following:

- (i) To consider my applications for promotion as per the provisions of UGC Regulations, 2018 (exemptions provided in Regulations).
- (ii) To consider my service period from 23.09.2005 to 23.09.2010 for my promotion from level-10 to level-11 at the time of joining NIFTEM.
- (iii) To consider my service period during which I served on level-11 at my previous organization (from October, 2010 to July 08, 2014) for my promotion from level-11 to level-12 and promote me to level-12 from October, 2015.

Thus, if the service rendered at the AGP of Rs. 7000/- w.e.f. 01.10.2010 is considered he becomes eligible for Promotion/Assessment to the next higher level (i.e. level-12)\* w.e.f. 01.10.2015 and to the next Level-13 on completion of 03 years i.e. w.e.f. 01.10.2018 provided he meets the requirements of API Score\*\*

\*Score for Level-11 to 12 this is adequate score.


